# 2018 critical illness claims at a glance



Last year we helped more customers than ever before, paying **96.5%** of all individual protection claims. We're proud of how we've been there for over **26,000**, paying out over **£957m in 2018** alone to life and terminal illness, critical illness and income protection customers. Here's a snapshot of our critical illness claims...

#### What is critical illness cover?

Our critical illness cover pays out if you are diagnosed with, or undergo surgery for, a critical illness that meets our policy definition during the policy term and then survive for at least 10 days. We only cover the critical illnesses we define in our policy and no others. It doesn't pay out if you die.

We'll only pay the full cover amount once. Please be aware that if you stop paying premiums or cancel the policy, you'll no longer be covered, and you won't get any money back. Also, we'll only make a payment if a successful claim is made.






